Philip was an ebullient character, and his experience and knowledge of Freedom matters will be sorely missed, as will his presence at our Court and General Meetings. An anonymous Greek philosopher wrote "It is not what is written on tombstones that matters, but what is written on the hearts of men." Let this be his epitaph.

Philip James Bowman. (1935 - 2009):

An Appreciation.

I have known Philip for many years, both as a friend and colleague within the world of the Freemen of England and Wales. Whilst I am by no means unique in this - there are many who have closer links with the family, I have been associated with much of his work within the Association.

Philip was born within the walls of the City of York and has remained true to its ethos and importance throughout his life and career. He joined the family firm of James Bowman & Son and worked successfully for many years. He and Margaret, his wife, have lived in York until very recently when they moved to the small village of Stamford Bridge (no connection to Chelsea!)

Philip served as a City of York Councillor representing Monk Ward and left his mark upon the Council. His great interest in the theatre is exemplified by his being the producer for the Monkgate Players, a role which he added to his interest in and production of several York Mystery Plays. This expertise he utilised for the Guild of Scriveners. Philip became a member of the York Gild of Freemen in 1989 and was subsequently its Master in 1998/99. He was a Freeman of the City of London and a member of The Company of Fellmongers of Richmond, the Wheelwrights Livery of London and an associate member of Coventry and Lincoln.

Within the ranks of FEW, Philip served on the Executive for some years and became its President from 2005 to 2008. He died holding the office of Immediate Past President.

One of Philip's great attributes was that of being able to speak with authority and sonority on almost any topic. His official speeches to the Freemen in a wide variety of locations were invariably to the point, succinct and without compromise. In debate, his points of view were always relevant and worth consideration. His memory was formidable and he could be called upon to speak without notice secure in the knowledge that he would not falter.

His untimely death will leave a void on the Executive, but this pales into insignificance compared with the sense of loss on the part of his family and many close friends.

News From The Guilds.

Coventry.

On 16th June the Guild welcomed our more venerable Freemen to the Senior Freemen's Evening at the Coundon Club, for a social meeting and buffet. A raffle helped start the new Master's Charity Appeal Fund.

On 27th June our Master and Clerk represented the Guild at the Cathedral's Armed Forces Day service, and then joined the Lord Mayor for the march past and salute at the Council House entrance platform.

On the 24th July the Guild welcomed the new Lord Mayor, councillor Jack Harrison MBE JP to the ceremonial role of Guild President for his term of office at a formal dinner in the Guildhall Crypt. The outgoing Lord Mayor, Councillor Andy Matchet, and Past Master Andy Sanders were presented with plaques in recognition of their services to the Guild.

On the 23rd August the Master's Fun Day charity event was held at the Coventry RAFA HQ. Over £300 was raised from skittles, other tests of skill, and a raffle. The Master Jim Parry treated Guild members to cakes and tea, whilst the Old Boys of the Coventry School of Music and lady cellists entertained us during the afternoon.

On 30th March the Master led a sponsored walk between the Warwickshire villages of Bretford and Ansty to further augment his charity fund for heart defibrillators.

The Coventry Guild was very saddened to hear about the passing of FEW Past President Philip Bowman. Philip had been an associate member of the Guild since 2006, and had attended the Coventry Banquet and church services for many years.

LEICESTER.

Soon after, a dozen hardy souls braved torrential rain to book in to the Gild's guided **tour of Everards Brewery** in Leicester. A splendid buffet lunch with plentiful samples of excellent beers was later enjoyed.

On a very active Sunday 12th July, thirty five freemen and friends enjoyed an excellent day at **Woburn Safari Park and Abbey**. After a drive through the Safari park seeing lions, tigers, elephants and many more animals roaming freely, the party moved on to the splendours of Woburn Abbey and its stately rooms. The same day, six Freemen and their ladies were invited by the Lord Mayor to attend the **Civic Service** at Leicester Cathedral, and a further three Freemen and their ladies represented the Gild at St Mary de Castro Church for a **farewell service** for the Reverend David Cawley, who was leaving the parish after 14 years. Afterwards, Michael Ayres, Deputy Master, presented David with a Gild plaque to thank him for the warm welcome he always gave the freemen, especially during the 900th Anniversary celebrations in 2007.

Annual General Meeting 2009. Stafford.

FEW Open Forum Held on Saturday 5th September 2009 prior to the Annual General Meeting Items Raised

1) Howard Pate - Chester.

Howard requested any information on the appointment of a new FEW Patron. The President, Colin Hardcastle replied, stating that the Executive Committee had been notified by Tony Sharp at its meeting yesterday, that an eminent person had been approached, and that the position was being considered, with the response expected by November.

2) Howard Crapper - Oxford.

Howard, noting that Oxford had recently admitted Lady Freemen for the first time, asked whether the words of the Freemens' Hymn should be amended to recognise "daughters" as well as "sons". He was notified that any changes would need the approval of the Ward family, as it was Harry Ward's wife who had composed the original words, but hi the meantime, he was asked to suggest suitable new wording. The Deputy President, Peter Dale, felt that any proposed changes should not be implemented until after the forthcoming Bill affecting the Freedom had received its assent, as there may be all male guilds which might object until the law is changed.

3) John Edwards - Stafford.

John asked whether constitutional changes had been necessary when Oxford recently introduced Lady Freemen. Howard Crapper replied that having gone to the Privy Council in order to obtain the right to have Lady Freemen, Oxford had accordingly been authorised to modify its Constitution to reflect the new situation.

4) Alfred Eley - Stafford.

Alfred requested clarification on the subject of attaining the Freedom by apprenticeship when NVQs are considered. Capt. Stephen Healy replied by stating that currently the Stewards Committee of Newcastle upon Tyne was carefully considering this matter. He noted that the probable outcome would be that the terminology "apprenticeship" when referring to the Freedom, can only mean an apprentice who is indentured to one individual - the Master, working

in just one premises, and not when he is indentured to a corporate master, or is working on an NVQ. Capt Jim Evans agreed with this reasoning, noting that the Coopers Gild of Berwick-upon-Tweed had indeed changed its rules some 300 years ago, but only to allow necessary occasional working away from the master's premises, when, Berwick-upon-Tweed being a seaport, the work of making or restoring barrels had to be conducted on board a ship.

Minutes of the 43rd Annual General Meeting of the Association of Freemen of England and Wales held on Saturday 5th September 2009, in The Council Chamber of the County Council Buildings, Stafford

Although produced as a meaningful record of the proceedings, these minutes in no way constitute a verbatim transcript of the meeting.

Following the Call to Order, the President, Colin Hardcastle, accompanied by the Worshipful Mayor of Stafford, Councillor Jean Tabernor, entered the chamber and took their places.

The FEW Opening Prayer was pronounced by the Hon Archivist. Alan Fallows.

The President introduced and welcomed the Mayor, requesting her to open the meeting. In doing so, she extended a very warm welcome to everyone, hoping that their stay in Stafford would be most enjoyable. Unfortunately, due to another engagement in her busy mayoral schedule, she was unable to stay for the meeting itself, but before she departed, the President was pleased to present her with a FEW plaque.

The President then pronounced a Tribute to Immediate Past President, Philip Bowman, who sadly, had suddenly passed away on 20th August. A copy is appended. Following this, he read out the names of those members who had also died during the previous twelve months. A moment of silent reflection was then observed by everyone present.

Apologies for non-attendance were received from:-Michael Ayres, Leicester; Tony Chettle, Leicester; Eric Critchlow, Leicester; Eddie Errington, London; Sylvia Errington, York; Malcolm Green, Haverfordwest; Janet Honnoraty, Warwick; Michael Honnoraty, Warwick; David Hudson, Hale; Evelyn Hudson, Hale; Moyra Johnson, York; Sam Lee, Newcastle upon Tyne; Colin McNae, Chester; Hilarie McNae, Chester; Joe Petty, Newcastle upon Tyne; Mary Pickering, London; Alan Robson, Newcastle upon Tyne; Ray Stone, Oxford; William Strawn, Alnwick; and Wayne Warlow, Cardiff.

The minutes of the 42nd AGM of FEW, held on 29th August 2008, were approved as a true record of those proceedings, following a proposal from Roy Folland, seconded by Norman Offield, and were signed by the President. There were no matters arising.

The President, Colin Hardcastle then presented his report. A copy is appended.

Deputy President, Peter Dale, reported that as the President has been in good health, there had been no necessity for him to deputise on any occasion. However, he had been consulted by the President on various issues, and his observations had been acted upon. He noted that he had

been pleased to represent FEW at the recent funeral of Philip Bowman.

A copy of the report of the Vice President, Gordon Varndell, is appended.

Each Warden was introduced in turn by the Vice President, and gave their individual reports as follows:-

Warden for the North, Capt. Stephen Healy - copy appended.

Warden for the North East, Emma Reid-Chalmers - copy appended. A point of order was raised by Tony Sharp, that Emma was deviating from her brief of reporting on the activities of the guilds within her area, and was airing personal opinions concerning FEW policies. Emma explained that these had been necessitated by comments received from her area guilds.

Warden for the East, Norman Offield - copy appended.
Warden for Wales, Roy Folland - copy appended.
Warden for the North West, Leslie Morgan - copy appended.
Warden for the West, Howard Crapper - copy appended.
Warden for the South Midlands, Derek Austin - copy appended.
Warden for London and the South East, Tony Sharp — copy appended.

Stephen White presented his Hon Treasurer's Report. A copy is appended. Derek Austin queried the connection between the FEW website and Grimsby. Emma Reid-Chalmers, who together with Capt. Stephen Healy, had been appointed to oversee the production of the website, explained the situation, and reported on progress to date. The meeting then fully approved the accounts following a proposition from Tony Sharp, who also expressed sincere thanks on behalf of FEW for the way that Stephen as co-opted Hon Treasurer, together with the assistance pf John Tolley, had brought matters back onto a meaningful footing, following the debacle caused by the inactivity of, and lack of co-operation by, Stan Brown, the previous Hon Treasurer, who had been appointed at the 2008 AGM.

Eileen Forth presented her report as Hon Membership Secretary. A copy is appended.

Tony Sharp presented his Hon Editor's report. A copy is appended. He explained how the overall costs of producing the FEW Journals, were split between those of the Hon Editor for the editorial content - articles, photos etc., and those of the Hon Secretary for the constitutional content - AGM/Court minutes, agendas, notices etc.

Alan Fallows presented his Hon Archivist's report. A copy is appended.

In the absence of Hilarie McNae, no Officer Without Portfolio Report was presented.

Tony Sharp updated the meeting on the progress to date of the Government's Local Democracy, Economic Development and Construction Bill. A copy of his notes is appended.

The meeting was informed of the Executive decision to discontinue the idea of producing a new book updating and replacing Harry Ward's original book "Freemen in England", in favour of the considerably cheaper method of putting all the currently held information on to compact disk. At the same time, Charles Sparrow's series of addresses to FEW AGMs, together with Maurice Pickering's essay on the history of the Freedom, could also be available on disk. The probability is that such CD(s) will be distributed free of charge to all members, by being included in with a future issue of the FEW Journal. To avoid any future confusion, the meeting agreed that the title "Harry Ward 2" will now be dropped.

Elections for the 2009 - 2010 FEW Executive Officers then took place, following the President's reading out of a detailed statement of the way that these would be correctly conducted in order to be completely transparent and accurate, thereby avoiding the possibility of any subsequent disagreement or argument. Two offices were the subject of election:-1) Deputy President, contested by Prof. Peter Dale and Alan Fallows; and 2) Vice President, contested by Tony Sharp and Gordon Varndell. Before the ballot itself was commenced, the Hon Secretary, Ron Leek, read out the following nominations for offices which were not being contested:- Hon Secretary - Ron Leek; Hon Treasurer - Stephen White; Hon Membership Secretary - Eileen Forth; Hon Archivist - Alan Fallows; Hon Editor - Tony Sharp; and Officer Without Portfolio - Hilarie McNae. The meeting agreed that these uncontested persons were deemed elected. Following the subsequent lengthy ballot for the offices of Deputy President and Vice President, and then the considerable time required for the results to be determined by the impartial tellers provided by the Stafford Guild, the results were handed to the President who announced that the following persons were duly elected:- Deputy President - Alan Fallows; and Vice President - Gordon Varndell. The President, congratulating Alan and

Gordon, presented them with their medallions of office; following which, he presented his Consort, Emma Reid-Chalmers, with the newly introduced President's Consort's Jewel, which he had presented to the Association as a personal gift at its June Court Meeting in Berwick-upon-Tweed.

Gordon Vamdell announced that he was proposing no changes to the current Wardens or their areas.

Any Other Business:

- 1) Costs for establishing the new website were reviewed by Stephen White, and following discussion and a proposal by Colin Hardcastle seconded by Gordon Varndell, the meeting agreed that up to £1000 should be apportioned to setting up the best site possible.
- 2) In order to expedite proceedings, the meeting approved the suggestion that Wardens' reports should be kept as short as possible, and submitted in writing to the Vice President in advance of the appropriate Court or Annual General Meeting.
- 3) The question was raised as to whether FEW should hold Public Liability Insurance. This will be investigated by the Hon Treasurer.

The 2010 AGM will be held from Friday 10th September to Sunday 12th September in Berwick-upon-Tweed. The 2011 AGM is scheduled to be held in Pembroke.

Following the Closing Prayer, the President formally declared the AGM closed, and led by the FEW Mace carried by the Stafford Mace Bearer, proceeded from the chamber.

Reports:

Presidents Report:

The Presidency of F.E.W. Is like a football match- a game of two halves. So as we reach half time it is an opportunity to reflect on the first half and identify where, if anywhere, we made errors or could have done better. I passed this on to the Vice Chairman of the Stewards Committee and he asked me to acknowledge that invitation with thanks in this report. He declared that, with regret, it was felt that attendance would be seen as inappropriate at this stage, although he much appreciated the sentiments behind the invitation.

Warden for the North East: Emma Reid-Chalmers

I start where I left off last time with the City of York Gild of Freemen holding their AGM where after an undeniably successful year Tom Gibson handed the mantle of Master on to our very own Membership Secretary, Eileen Forth. Our Vice-President. Gordon, is her Consort. The event was gate-crashed by civic dignitaries and a highly successful and enjoyable event kicked started Eileen's year. If the latest newsletter is anything to go by is going to be a busy one with an inter guild guiz night, talk by Veronica Bird OBE, ghost walk and supper and possibly golf. Already Eileen has attended the Mansion House at the invitation of the Lord Mayor to welcome Mrs Elizabeth Brockbank, from Australia after the ceremony making her a Freeman of the City of York. This was on 27th July, and was closely followed by, what is becoming the traditional Yorkshire Day Charity Concert at Queen Margaret's School, Escrick. There has also been a visit to Burnby Hall Gardens, Pocklington and a Boating Regatta at which, I am reliably informed, our President obtained preferential car parking due to astute use of his Freemen credentials. This resulted in the local constabulary supporting the event. York has, again, produced a colourful and professional Annual Year Book, and there are a number of photographs of

The Freemen's stand was kept busy answering queries on the Freedom and eligibility issues over the July weekend. Several weeks later the Lord Mayor was welcomed into his ceremonial role as Guild President for his year of office, at a dinner in the Guildhall. In August the Master's Fun Day event, and also a sponsored walk, helped raise funds for his charity appeal, which hopefully will see a defibrillator provided later this year for the resuscitation of heart attack victims in the Cathedral precincts.

Leicester Freemen's Gild enjoyed a theatre trip and guided tour of Everards Brewery in the local area, then later in July a coach trip to Woburn Safari Park & Abbey. The Gild was also represented at the Civic Service in the Cathedral, and the Armed Forces Day parade and service. Tomorrow the Leicester coaches

Our latest recruit the **Henley-in-Arden Court Leet & Court Baron** had an excellent write up in the current FEW Journal, courtesy of our Editor, and I look forward to attending their annual meeting in the 15th Century Guildhall in November.

WARDEN FOR LONDON & SOUTHEAST; Tony Sharpe

I have nothing to add which has not been published in the News from the Guilds section of the Journal, concerning Southwark, Rochester and the Constructors of London social events. However, I was approached to advise Medway Council on an attempt by an individual to encroach on the Freemens' rights on the river. A self-employed trawler owner of 56 years of age from outside of the area demanded to be made an 'apprentice' to allow him to fish on the Medway.

There was an initial difficulty because in our era of political correctness, all that someone has to do is cry 'discrimination' and our local authorities immediately respond on the defensive. I advised Medway's officers that it was unlikely that they or the Freemens' guild could be cited as parties by a claimant and even if they could there was no formal offer of employment and training being made by anybody. At the 'Case Management Stage' a preliminary to tribunal hearing in August, the Employment Judge made very short shrift of the claimant's arguments and pointed out that even if he could prove his case then the damages or compensation would be set at Nil. Editor's Report:

Format and distribution.

The Trinity Journal (159) was distributed to the Membership and Court by the late July 2009. It was a 44 page edition of just over 19,800 words which meant it was the largest ever produced by myself, principally due to the 'Hansard' report on the new Bill and AGM constitutional materials. There were 481 copies distributed at a cost of £334.32 If we add the cost of Journal 156 (Annual Record 2008) of £435.05 Journal 157 at £568.39 and Journal 158 at £462.50

this equals £1,800.26. As the notional Budget allocated by the Treasurer was £2,700 for this purpose, I am most pleased to announce a surplus of £899.74. Both postage and production costs are stable and accounted for.

May I remind delegates that if they want additional copies to be distributed to their guilds then all they need do is contact the Hon Secretary who will make the necessary arrangements, but these must be for named individuals and addressed to them.

I would suggest that there is no need to set a budget for all FEW publications of no more than £2700 per annum for some years yet. I commend my Report to the AGM.

Archivists report.

There have been no calls upon the archives since our last meeting. With reference to the two matters I have been asked to pursue, namely land registration and unitization the situation is as follows:

- 1. Land Registration:- Papers are still under preparation for submission to chancery chambers but have been held back as I feel that I need more information regarding individual gilds historical adaptation of their pasturage rights. The question that has become prominent is this. If pasturage has been commuted to a money payment in lieu (or other alternative to actual pasturage) does that pasturage right still exist, or just the right to the commutation? This leads us to the secondary question that if such rights are extant in either form, what form of registration is applicable under the act?. I obviously want to make sure that my proposals to Chancery include any aspect which may assist a favourable opinion.
- 2. Unitization:- This question has further delayed the previous item as it becomes more urgent to complete. I have found in Shropshire that the Unitary Authority have decided to completely ignore Dept of Communities and Local Government guidelines, and maintain control of freemens affairs. This I consider to be totally inappropriate and have now submitted a formal request to the authority that all contact with freemen must be the responsibility of the "local" authority where the freedom is sited, i.e. the town, borough or parish where the freedom arose. This application has been made on behalf of Bridgnorth and Shrewsbury but if we can set a precedent it will be useful if a similar situation arises elsewhere.

The Land Registration Act continues to present some Guilds with difficulties, largely because Ancient Rights are not formalised, but the Association continues to offer what help it can with these matters. The Association recognises that recent Charities legislation could present some Guilds with difficulties, and continues to engage with the appropriate authority in expressing its views.

The Association is represented at a number of formal and ceremonial functions throughout the Country, and the President particularly welcomes the opportunity to attend those ceremonies where new Freemen are created.

The Association was actively involved with a Parliamentary Bill drafted by the Department of Constitutional Affairs, which, if enacted, would enable Guilds to change their local rules of admission, thus allowing women into the Freedom where, currently, they are denied. Work is also progressing on a new book about the Freedom in England and Wales, to replace that produced many years ago by the Founder President, the late Harry Ward.

The Wardens of the Association continue to reach out to Guilds within their Warden Areas, and provide a valuable social link between member Guilds seeking outside contact.

REPORT ON THE LOCAL DEMOCRACY BILL

In the last Journal I added a gloss to the Hansard report that the Bill was to pass to the 'Report Stage' and 'Third Reading' of the Commons and that Jim Cousins amendment had not been tabled for that part. I was informed of this by Lord Graham who fully expected that it would get Royal Assent, unchanged, in very late July/ early August. That was all true at the time of going to press.

However, the Government sent Parliament into Summer Recess earlier than expected and so the Bill did not get to its Report Stage. That will now take place at the beginning of the next Session from the 12th October.

To explain what this means practically: The Bill was passed from the Lords to the Commons and it had not been amended at the Commons Committee Stage which lasted some weeks, although

guillotined. The Report Stage will be guillotined at just one day and then will pass directly to its Third Reading. There is no indication of whether Jim Cousins' amendment will be tabled for the Report Stage, but as the Bill was not changed at Committee Stage it will be unlikely to be accepted even if debated, or rather discussed.

The Bill will then return to the Lords as the originating House and as it has not been changed by the Commons it shall pass through the Lords, 'on the nod', and go to Royal Assent. As to Lord Graham clause; The only Amendment accepted by the Government was his Clauses and the only Clauses 'welcomed' by the Opposition in the Commons, who opposed the Bill in all parts, was those same Clauses.

An Appreciation.
